Notice Inviting Tender

Indian Institute of Technology (IIT), Jodhpur, Rajasthan (hereinafter referred to as the “Institute”) an Educational Institute of National Importance, invites sealed tenders for renewal of the following item. You are requested to quote your best offer along with the complete details of specifications, terms & conditions. Quotation should be sealed and superscribed with tender number and due date of submission and address to:

The sealed quotations should reach the Institute, latest by March 02, 2015 by 03:00 PM and it will be opened on same day at 04:30 PM in the Conference Room, Administrative Block of the Institute in the presence of the bidder(s) or their authorized representative(s), who will present at the scheduled date and time.

Terms & Conditions:

1. **Earnest Money Deposit:** The bidder shall be required to submit the Earnest Money Deposit (EMD) for an amount of Rs.15,000/- (Rupees Fifteen Thousand only) which is refundable and a non-refundable tender fee of Rs.500/- (Rupees Five Hundred only) by way of demand draft only. The demand drafts shall be drawn in favour of “Director, IIT Jodhpur” payable at Jodhpur.

The EMD of the successful bidder shall be returned after the completion of contract / order and for unsuccessful bidder(s) it would be returned after award of the contract. Bid(s) received without demand drafts of EMD and tender fees shall be liable for rejection.

The firms who are registered with National Small Industries Corporation (NSIC) / or Small Scale Industrial (SSI) are exempted to furnishing the EMD and tender fee.

2. **Rates:** Rates should be quoted in Indian Rupees (INR) on FOR destination at IIT Jodhpur, Old Residency Road, Ratanada, Jodhpur – 342 011, inclusive of all the charges, with breakups as:

- (i) Basic Cost.
- (ii) Taxes (as applicable)
- (iii) Total Cost (F.O.R at IIT Jodhpur).

3. **Validity:** The quoted rates must be valid for period of 120 days from the date of closing of the tender. The overall offer for the assignment and bidder(s) quoted price shall remain unchanged during the period of validity. If the bidder quotes the validity shorter than the required period, the same will be treated as unresponsive and it may be rejected.

4. **Delivery:** License should be renewed within 4 weeks from the date of issue of the purchase order. If the supplier fails to renew of the licenses on or before the stipulated date, then a penalty at the rate of 1% per week of the total order value shall be levied subject to maximum of 10% of the total order value.

5. **Payment Terms:** 100% payment of the total order value shall be released after the successful installation / commissioning of the ordered goods against the submission of the test report duly certified by the Institute Authority.

6. The bidder must enclose a certificate from the parent company as being an authorized dealer / distributor of the quoted products. The bid received without such valid authorization certificates shall be rejected.

7. Bidder shall submit a copy of the tender document and addenda thereto, if any, with each page of this document should be signed and stamped to confirm the acceptance of the entire terms & conditions as mentioned in the tender enquiry document.

8. **Applicable Law:**

- The contract shall be governed by the laws and procedures established by Govt. of India, within the framework of applicable legislation and enactment made from time to time concerning such Commercial dealings / processing.

- Any disputes are subject to exclusive jurisdiction of Competent Court and Forum in Jodhpur, Rajasthan, India only.
- The Arbitration shall be held in accordance with the provisions of the Arbitration and Conciliation Act, 1996 and the venue of arbitration shall be at Jodhpur. The decision of the Arbitrator shall be final and binding on both the parties.
- Force Majeure: Any delay due to Force Majeure will not be attributable to the supplier.

9. After due evaluation of the bid(s), the Institute will award the contract to the lowest evaluated responsive tenderer.

10. Conditional bid will be treated as unresponsive and it may be rejected.

11. The Institute reserves the right to accept in part or in full or reject any or more quotation(s) without assigning any reasons or cancel the tendering process and reject all quotations at any time prior to award of contract, without incurring any liability, whatsoever to the affected bidder or bidder(s).
