विषय/Subject: Institute Overhead Charges.

In the suppression of all the earlier Notifications/Office Orders, the revised norms for the Institute Overhead in all the projects registered with the Office of R&D are as follows:

1. Any project registered with the Office of R&D with external funding should be charged Institute Overhead as per the category of projects, including the projects funded from Section 8 Company.
2. Award money / Unrestricted Grant will be considered under the Consultancy Project category.
3. The various Government Funding agencies (like DST, DBT, CSIR, BRNS, ARDB, DRDO, ISRO, etc.) have their own overhead norms. In those cases, the Overhead will be charged as per Government Funding agency norms.
4. The revised Overhead charges are as:

Sr. No.	Category of Project	Rate of Overhead Charge
1.	Sponsored Research Project	20%
2.	Consultancy Project	25%
3.	Fellowship	20% or as per the government funding agency norms.
4.	Fellowship and Research	
5.	Travel Grant	Nil or as per the government funding agency norms.
6.	Institute Project	Nil
7.	International Project	30% or as per the government funding agency norms.
8.	Workshop/Conference	15% or as per the government funding agency norms.


5. The collected Overhead will be distributed as:

Sr. No	Category of Project	R&D OH	DDF/ CDF	PDA	CAF
1.	Sponsored Research/Fellowship /International etc.	65%	10%	20%	5%
2.	Consultancy Project	100%	Nil	Nil	Nil
3.	Conf. / Workshops	100%	Nil	Nil	Nil

The revised Overhead rate will be admissible from the date of the notification. The projects registered before the notification shall be governed by the previous overhead norms. All Projects registered after the date of notification shall be governed by the new norms.
