All the members of BoG echoed the views expressed by the Chairman, BoG. The Chairman specifically commended the efforts by the Institute to optimize its financial resources, which led to rationalization of Institute expenses. 	<p>The Board was briefed that on the recommendation of the Finance Committee in its 35th Meeting held on 25th June 2025, the Annual Accounts for the Financial Year 2024-25 was presented to the Board of Governors for their approval. After getting approval from the Board of Governors in its 40th Meeting held on 25th June 2025, the Institute submitted the same to the Office of CAG Branch: Jaipur for commencement of the Audit. The Office of CAG deputed a team from 11th August 2025 to 22nd August 2025 to undertake the Audit of the Annual Accounts of the Institute for the Financial Year 2024-25. The Institute received the Draft Separate Audit Report (SAR) on 7th October 2025 (by email) and replies to the draft SAR were submitted vide Letter No. IITJ/F&A/2025-26/24 dated 13th October 2025 to the Office of CAG.</p>
	<p>Further, the Board of Governors was apprised that the Finance Committee in its 36th meeting held on 26th November 2025 noted that the Final Separate Audit Report (SAR) on Annual Accounts of the Institute for FY 2024-25 and Certified Annual Accounts have not yet been received from the Office of CAG. The Finance Committee discussed minor observations by the CAG and expressed satisfaction on the overall report. The Finance Committee authorized the Chairman, Board of Governors/ Finance Committee for adoption of the Final Separate Audit Report (SAR) on Annual Accounts for the FY 2024-25.</p>
	<p>On the recommendation of the Finance Committee, the Board of Governors authorized the Chairman, BoG to accord approval on adoption of the Final Separate Audit Report (SAR) on Annual Accounts for the FY 2024-25 so that the same can be submitted to the Ministry of Education for laying on the table of both houses of the Parliament within time limit prescribed by the MoE.</p>
	<p>(ii) Annual Report of the IIT Jodhpur for FY 2024-25</p> <p>The Annual Report of the Institute for FY 2024-25 was tabled during the meeting. The Board of Governors appreciated the Annual Report and approved the same. Further, the Board suggested the Institute to submit both English and Hindi Versions to the Ministry of Education, Govt. of India for laying on the table of both houses of the Parliament.</p>

41.3.7	<p>To consider and approve to withdraw the scheme for Top Twenty JEE Rankers joining IIT Jodhpur, provided their AIR (UR) is higher than 3000</p> <p>The Board of Governors was apprised that the existing scheme of giving laptops to top 20 JEE Rankers joining IIT Jodhpur was approved in the year of 2019, and it is felt to review the same as it did not serve the purpose to the extent it was anticipated while launching the scheme. Therefore, it is proposed to withdraw this scheme.</p> <p>The Board of Governors approved to withdraw the scheme for giving laptops to Top Twenty JEE Rankers joining IIT Jodhpur, provided their AIR (UR) is higher than 3000.</p>

41.3.9	<p>To consider and approve the proposal towards discontinuation of Travelling Allowance for Candidates Appearing for Non-Faculty Recruitment Examinations/Interview at the Institute</p> <p>The Board of Governors was briefed that in accordance with the provisions of the Statutes of the IIT Jodhpur, Point No. 17 (14) "<i>Candidates selected for interview for a post under the Institute may be paid such travelling allowances as may be determined by the Board from time to time in this behalf.</i>", and the Recruitment and Promotion Rules – 2021, states "<i>TA reimbursement will be made for person attending the Written Test and Trade Test for Group B & C posts and for persons attending the Interview (in person) for Group A.</i>" the Institute currently provides Travelling Allowance to Outstation applicants who are called for tests and subsequently qualify for the final stage of the selection process (i.e., skill test/interview). Such candidates are eligible for reimbursement of travel expenses for the journey from their Correspondence Address to Jodhpur and back by the shortest route.</p> <p>The BoG was further briefed that the Institute has received an exceptionally large volume of applications for the Non-Teaching Recruitment Positions advertised against Advt. No. IITJ/O(E-II)/2024-25/Non-Academic Staff/57 dated 8 April 2024,</p>

	<p>amounting to a total of 20,906 applications. Processing Travelling Allowance claims for outstation candidates in such high numbers will impose a substantial financial burden on the Institute. Additionally, the scrutiny and settlement of a large number of TA claims is a time-consuming exercise and requires considerable administrative manpower, which is currently constrained. This situation is expected to prevail in future recruitment cycles for the Non-Faculty recruitments. Therefore, the Institute is proposing to discontinue Travelling Allowance for Candidates Appearing for Non-Faculty Recruitment Examinations/Interview at the Institute.</p> <p>After detailed deliberations, the Board of Governors approved the proposal towards discontinuation of Travelling Allowance for Candidates Appearing for Non-Faculty Recruitment Examinations/Interview at the Institute.</p>
