

	The Senate admitted the proposal with the following changes and suggestions: (1) In the M.Tech. (EE) Program, a Mathematics elective may be included; (2) In the M.Tech. (ME) Program, another elective may be added in the II Semester; (3) Upto 15 students may be admitted to the Program each year; and (4) The minimum academic qualifications may be clearly spelt out for admissions to the M.Tech. (EE) and M.Tech. (ME) Programs.

	The Senate noted the matter with concern, and suggested that the Academic

	before recommending to Senate for any action. Also, the Senate was informed that a
	communication was received from Onkar Krishna seeking withdrawal from the
	Program; the Senate noted with deep regret the withdrawal of the student from the

3.2.3	Approval of New Courses of B.Tech., M.Tech., and Ph.D. Programs The Senate admitted the proposals of four new courses.

	The Senate discussed the matter in detail. It observed that the Institute is operating
	from a Temporary Campus with severe space crunch, and has shortage of Faculty
a p	Members. Hence, the Senate suggested that the matter may be considered, when the
	Institute moves to its Permanent Campus.
5.2.8	Reserving slots for German students in Master's Programs at IIT Jodhpur
	under the 'Sandwich System'
	The Senate admitted the proposal, including the Tuition Fee waiver to the Visiting German Students.
5.2.9	Waiver of compulsory courses to B.Tech. students, otherwise meeting all
250823252	other requirements for graduation in July 2015.
	The Senate discussed the matter, and sought detailed and correct information from the
	Academic Committee to take an informed decision.
5.2.10	Inviting Students Representatives as observers in Senate Meetings
	The Senate discussed the matter in detail. The Act and Statutes of the Institute do not
	have provision for Student Members in Senate. It observed that the inputs of the
	students are received formally at the Academic Committee. But, to bring in students
	into the informed decision making process, it may be important to consult students on
	specific matters that may arise in the floor of the Senate. For this reason, the Senate
	admitted the request of students with the following conditions:
	(1) Two students will be Special Invitees to Senate Meetings, namely General Secretary and Secretary handling academic matters of the Students Gymkhana;
	(2) They shall present the students view when requested by Chairman, Senate;
	(3) They will be present during Part A of the Senate Meetings, when only general and
	non-sensitive Agenda items are discussed, and not during Part B of the Senate
	Meeting; and
	(4) They shall maintain the decorum of the Senate.
5.2.11	Provision for Deferred Placement to Graduates
5.2.12	The Senate admitted the proposal.
	Guidelines for Ph.D. Thesis Examiners The Senate decided the following additional guidelines:
-	(1) The examiners shall have at least 6 years Post-Ph.D. experience;
	(2) No two proposed examiners shall be from the same organization; and
	(3) They can be Faculty Members or Scientists, of standing and repute.
	The Senate clarified that the list provided by the Ph.D. Thesis Supervisor is not binding
	on the Chairman, Senate. In special instances, the Chairman, Senate, may identify
	examiners beyond in the list.
5.2.13	Suitability of AMIETE and ALCCs with Certificates Holders for admissions to
	M.Tech. and Ph.D. Programs
	The Senate sought more information from the Academic Committee, related to the
	Laboratory work done during the said two programs. In particular, it sought
	information on whether or not the marks sheet of the Certificate Programs clearly
	record the Laboratory work done. Further, the Senate sought a report on the practices
	adopted by other IITs, including the Mentor IIT, i.e., IIT Kanpur.




5.2.14 Organising Convocation 2015 The Senate authorized Chairman, Senate, to take necessary decisions in consultation with the Board of Governors.
