	The Chairman, BoG, welcomed all the members of the Board of Governors, especially, Dr. Hari Om Yadav, Registrar, IIT Jodhpur who was attending the meeting for the first time as Registrar & Secretary to the BoG. The Chairman, BoG also welcomed Sh. Alok Bansal, Director, Technical Education, Jodhpur, Govt. of Rajasthan who was attending the meeting as a representative of State Govt. Nominee. Then, the Chairman, BoG, called the meeting in order.
30.1.1	To Confirm the Minutes of the 29 <sup>th</sup> Meeting of the Board of Governors held on 17 <sup>th</sup> June, 2022 at Board Room, IIT Jodhpur
	The Board of Governors confirmed the Minutes of the 29 <sup>th</sup> BoG meeting held on 17 <sup>th</sup> June, 2022, as circulated.

30.1.2	Presentation by the two faculty members on their research work /accomplishments before the BoG
	As per the decision of the BoG taken in its 24 <sup>th</sup> Meeting held on 5.12.2020, the following two Faculty Members of the Institute made presentations before the BoG about their research work:
	<b>1. Prof. Ajay Agarwal,</b> Head, Department of Electrical Engineering presented the interdisciplinary research work, which he is currently involved in at IITJ. It is being planned in collaboration with AIIMS Jodhpur and NIFT Jodhpur. He explained the capabilities of various sensor platforms developed earlier. BoG Chair enquired if any of the nano-sensors demonstrated, can be realized in IITJ facilities. It was mentioned that nano-gap based sensor chips are being realized in the labs and these have been used for the analysis of organic honey. It was also mentioned that such devices should be used for real problems. Other BoG Members mentioned that these sensors can find multiple applications in molecular analysis relevant to biological systems. Prof. Ajay mentioned about the conducting yarn based wearable sensors being explored by him. BoG appreciated his R&D work.
	2. Prof. Somitra Kumar Sanadhya, School of Artificial Intelligence and Data Science (AIDE) & Dean (Digital Transformation), IIT Jodhpur presented broad directions of his research work to BoG members. He highlighted the important role of design and cryptanalysis of various cryptographic algorithms and security techniques for national security. He discussed his works in the directions of hash function cryptanalysis, block cipher cryptanalysis, password hashing schemes, approximate matching algorithms, use of quantum computers in cryptanalysis, and post-quantum secure encryption and signature schemes. He also touched upon hardware-software co-designs and FPGA implementations of Cryptographic algorithms for efficient realization of cryptographic protocols. The Board Members appreciated the work, and suggested that the Institute should focus on quantum algorithms. The BoG members also suggested Prof. Somitra to explore biological applications of his R&D work.
	The Chairman, BoG, and Members appreciated the presentations made by both the Faculty Members.

50.2	The Director presented the Institute Report before the Board of Governors :
	The Board of Governors was apprised that the number of Academic Programs of IIT Jodhpur reached <b>78 (including 2 proposed)</b> from AY 2022-23. The BoG was also apprised about the New Academic Programs, <i>i.e., B.S. Program in Chemistry, B.S. in Physics, M. Sc. in Computational Social Science, M.Tech. in Robotics and Mobility Systems, M.Tech. in Augmented Reality and Virtual Reality (AR &amp; VR), M.Tech. in Intelligent Communication Systems and Executive M.Tech. in Intelligent VLSI Systems.</i>
	The BoG was informed about the Program-wise Student strength of <b>3553</b> , Faculty strength of <b>233 (including 14 offered positions)</b> , and Non-faculty strength of <b>120</b> till date.
	The status of new Research & Development Projects was also presented before the Board of Governors and was apprised that the Institute has received <b>24</b> new R&D Projects and $\gtrless$ 8.32 Cr. Grant till 31.08.22 in currect FY which will be scaled up during the ongoing FY.
	<b>Re-imagining IITJ Finance: Task Force Suggestions</b> The Director brought out the suggestions of the New Financial Model Task Force on Re-imagining IITJ Finance as below:

The Chairman, BoG requested the Director to brief about the Business Plan as suggested by the Task Force. The Director informed the BoG that Infrastructure, Labs, Faculty, Consultancy, Patents, Technology Transfer, etc., are the assets of the Institute. And, in the present pattern of shrinking funding from the Ministry of Education, it is time for the Institute to use its assets to generate funds to support various academic activities of the Institute. Therefore, Institute has to have strategy of Finances to be managed with a "Business Plan" and "Cost Optimization" and to set up Financial Planning Unit with professional help with following Financial Plan:

	The recommendations of the Finance Committee made in its $26^{th}$ meeting held or $13^{th}$ September, 2022 were presented before the BoG. The BoG approved the recommendations of the $26^{th}$ <i>Meeting</i> of the Finance Committee. It made observations on the following items, and approved as under:
	26.1.4: Matter of HRA at par with "Y" Class city to the employees
	The Board noted and approved the following recommendation of the Finance Committee made in its 26 <sup>th</sup> meeting held on 13 <sup>th</sup> September, 2022 :
	"The Finance committee noted the various Action Taken by the Institute on the recommendations of the 25 <sup>th</sup> Finance Committee meeting held on 16 <sup>th</sup> June, 2022. The Finance Committee also noted the present status of the matter of Payment of HRA at par with "Y" class city to the Employees of the Institute. The FC noted that the employees of the Kendriya Vidhyalaya (KV), IIT Jodhpur had filed the matter before the Central Administrative Tribunal (CAT), Jodhpur and the Institute has already prayed to the CAT that the Ministry of Education may be involved in the process as IIT Jodhpur cannot take any action in this matter without MoE's approval.
	The Director expressed his deep concern about the long pending matter before the Finance Committee which is causing hardship to the Institute employees. The Director re-iterated that the Institutions in the vicinity of IIT Jodhpur such as, NIFT (An Autonomous Institute of Ministry of Textiles, GoI), Ayurveda University (Govt. of Rajasthan), Sardar Patel Police University (Govt. of Rajasthan), Indian Army Establishments, etc. ( <i>Central Govt. Institutions as well as Govt. of Rajasthan Institutions</i> ) have been paying HRA to their employees at par with "Y" Class city but the IIT Jodhpur is paying at par with "Z" Class cities which is against the Natural Justice. Therefore, the Director submitted that the Institute is left with no option other than to submit its appeal to the Visitor of the Institute (Hon'ble President of India).
	The Chairman stated that the position be presented to the Board of Governors for further direction."
	26.2.2: Adoption of Separate Audit Report (SAR) on Annual Accounts of the Institute for the Financial Year 2020-21
	The BoG noted and approved the following recommendations of the Finance Committee:

### 26.2.4: Revision of Rent Rate of Commercial establishments operating at IIT Jodhpur

The FC recommend the same to the Board of Governors for its consideration and approval."
