	At the outset, Sh. A. S. Kiran Kumar, Chairman, BoG welcomed the members of the Board of Governors and called the meeting in order.
	Thereafter, Dr. Somnath Ghosh, <i>Offg.</i> Registrar apprised the Board of Governors that the Hon'ble Education Minister, Govt. of India in his capacity as Chairperson, Council of IITs approved that Prof. Santanu Chaudhury, Director, IIT Jodhpur, shall continue to hold the charge of Director, IIT Jodhpur beyond 9 th December, 2023 till the end of the Academic Year, i.e., 30 th June, 2024 or till such time as the regular incumbent takes over or till further orders, whichever is earlier.
	The Chairman, BoG and Members congratulated the Director and noted same.

	<p>(ii) Minutes of the Pre-Convocation 12th Special Meeting of the Board of Governors, IIT Jodhpur held on 21st November, 2023</p> <p>The Board of Governors was apprised that the duly approved Minutes of the Pre-Convocation 12th Special Meeting of the Board of Governors, IIT Jodhpur held on 21st November, 2023 by the Chairman, BoG was circulated to all Members of the Board of Governors on 27th November, 2023 through email. The Minutes of the meeting was placed on the table during the Meeting. The Board of Governors confirmed the Minutes of the Pre-Convocation 12th Special Meeting of BoG, as circulated.</p>
<p>35.2</p>	<p>Institute Report by the Director, IIT Jodhpur</p> <p>At the outset, the Director apprised the Board of Governors that IIT Jodhpur conducted its 9th Convocation on 21st November, 2023. Dr. K. Radhakrishnan, Former Chairman, Space Commission & ISRO and Former Secretary, Department of Space Government of India was the Chief Guest for the Convocation Ceremony and delivered the Convocation address. Prof. Indranil Manna, Vice Chancellor, BIT Mesra and Former Director, IIT Kanpur and Dr. Vijay Chandru, INAE Distinguished Technologist, IISc and Co-Founder, Strand Life Sciences graced the occasion as Esteemed Guests. Shri A.S. Kiran Kumar, Chairman, Board of Governors, IIT Jodhpur presided over the Convocation Ceremony.</p> <p>The Director further briefed the Board of Governors that for the first time, the Convocation Ceremony was conducted in two sessions (i) First session for B. Tech. and M.Sc. graduands & (ii) Second session for Master's, M. Tech. MBA and Ph.D. graduands.</p> <p>It was also briefed to the BoG that during the 9th Convocation, Degrees / Diploma / certificates were awarded to 820 graduands.</p> <p>He further apprised the BoG that for the first time, the Institute honoured the following 3 internationally renowned personalities with Doctorate (Honoris Causa) Degrees:</p> <ol style="list-style-type: none"> 1. Prof. Paras Nath Prasad, University at Buffalo, SUNY currently Distinguished Professor of Chemistry, Physics, Electrical Engineering, and Medicine 2. Mr. Vinod Gupta, Everest Group LLC, USA 3. Prof. Rohini M. Godbole, Centre for High Energy Physics, IISc, Bengaluru, India <p>It was also briefed to the BoG that after the Convocation Event, Alumni Induction Program was organized for the Class of 2023.</p> <p>Later, the Director further apprised the Board of Governors that a delegation from SAMEER-Mumbai recently visited the Institute and explored possibilities for collaborative translational projects with the Faculty Members of the Institute in multidisciplinary as well as specialized domains.</p> <p>It was also informed to the Board of Governors that Prof. Dipankar Banerjee, Director, Aryabhata Research Institute of Observational-Sciences (ARIES) visited the Institute and delivered an Institute level Seminar on "India's Own Solar Space Observatory: Aditya L-1" on 30th November, 2023. The Director further briefed the BoG that detailed deliberations to explore the possibility of offering a joint Degree Program with ARIES was also held on 1st December 2023 and an agreement was made for a Joint Academic Programme - M.S.-Ph.D. Degree (with an exit option after M.S.) in astronomy-atmospheric science and technology between IIT Jodhpur and ARIES.</p> <p>The Chairman, Board of Governors, and members noted the Institute Report with appreciation.</p>

35.3	DISCUSSION ITEMS
35.3.2	<p>To consider and approve the proposal for the creation of the School of Design at IIT Jodhpur</p> <p>The Director apprised the Board of Governors that the Institute is currently offering a full-fledged Design Program M. Des. in XR Design and planning to offer Doctoral, Bachelors and additional Master's programs in Design.</p> <p>The Director further briefed the Board of Governors that the Senate in its 36th Meeting held on 16th & 18th November, 2023 recommended establishing the School of Design as an Academic Unit considering the multidisciplinary of Design and its value to students, researchers, faculty members, and entrepreneurs across the Institute in areas such as systems design, bio-design, Design of virtual and augmented experiences, information and pedagogy design, product design, design of digital artifacts are of contemporary interest towards creating an overall ecosystem.</p> <p>The Board of Governors requested the Director to apprise the BoG that the Institute has the required Basic infrastructure and Faculty Members to support the proposed School of Design. The Director briefed the Board of Governors that the Institute is already running a full-fledged Design Program M. Des. in XR Design.</p> <p>After detailed deliberations, the Board of Governors appreciated the initiative and approved the creation of the School of Design as per the provisions of Clause 5 (2) (h) of the Statutes of the Institute.</p>
35.3.3	<p>To consider and approve the recommendations of the 36th Meeting of the Senate held on 16th & 18th November, 2023 at IIT Jodhpur</p> <p>The Board of Governors noted and approved the recommendations of the Senate made in its 36th Meeting held on 16th & 18th November, 2023.</p>
35.3.4	<p>To consider and approve IIT Jodhpur (Prevention, Prohibition and Redressal of Sexual Harassment) Rules, 2023</p> <p>The Director briefed the Board of Governors that the Internal Complaints Committee (ICC) of the Institute has framed the Rules to govern any incident of sexual harassment within the Institute in line with the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013.</p> <p>The Board of Governors noted the same and approved the IIT Jodhpur (Prevention, Prohibition and Redressal of Sexual Harassment) Rules, 2023.</p>

35.3.5	To consider and approve institution of iHub Drishti Foundation Chair Professorship and Faculty Fellowship through IIT Jodhpur
	<p>The Director apprised the Board of Governors that the Government of India initiated the National Mission on Interdisciplinary Cyber-Physical Systems (NM-ICPS) program. Under this program, the Union Cabinet, through the Department of Science and Technology (DST), launched several Technology and Innovation Hubs (TIHs) across the country focusing on different areas of Cyber-Physical Systems such as Artificial Intelligence, Computer Vision, IoT, Data Science, and Security. Through a competitive process, the IIT Jodhpur was identified to host the TIH on Computer Vision and Augmented and Virtual Reality (CV and ARVR).</p> <p>The TIH at IIT Jodhpur has been named iHub Drishti. Later, iHub Drishti Foundation was incorporated as a Section 8 company to effectively manage the Mission mode Project.</p> <p>The Director further briefed the BoG that in line with the existing Tripartite Agreement between iHub Drishti Foundation, IIT Jodhpur (Host Institute) and NM-ICPS, DST Section 9.(2).(i) which mentions that "The HRD component will be executed jointly by the Hub and Host Institute (HI)", the Board of iHub Drishti Foundation considered that Chair Professor and Faculty Fellowship schemes will be implemented through the Host Institute (HI) i.e. IIT Jodhpur. Accordingly, an MoU has been signed between iHub Drishti Foundation and IIT Jodhpur for the execution of Chair Professor and Faculty Fellowship schemes through IIT Jodhpur and iHub Drishti Foundation has transferred ₹1.66 crores to the Host Institute (HI), i.e., IIT Jodhpur to establish Chair Professor and Faculty Fellowship as per the Institute's norms. The amount is inclusive of applicable Institute Overhead and GST, if any. The expenditure including honorarium, contingency and travel shall be met from the interest accrued on the corpus. The endowment fund shall be managed and maintained by IIT Jodhpur in perpetuity. In case any specific projects or studies are identified or conceived or facilitated through this MoU which may need separate funding as per the requirement of the project is to be decided based on mutually agreed terms between TIH and IITJ.</p> <p>The Director further briefed the BoG that the Chair Professor(s) and Faculty Fellow(s) will be selected through an open advertisement as per the norms of IIT Jodhpur. The tenure of the Chair Professor(s) and Faculty Fellow(s) will be one year from the date of appointment, extended upto one year.</p> <p>The Board of Governors noted the same and approved the institution of iHub Drishti Foundation Chair Professorship and Faculty Fellowship through IIT Jodhpur.</p>
