SP.13.1.2	<p>Institute Report by the Director, IIT Jodhpur</p> <p>The Director presented the brief Institute Report and apprised the Board of Governors on the following:</p> <ol style="list-style-type: none"> 1. The Institute is offering 91 Academic Programmes from AY 2023-24; 2. The present student strength reached to 4751 in the AY 2023-24 and out of 4751, 820 are the Ph.D. Students which is very good sign for Research Ecosystem;

3. The current Faculty and Non-Faculty Strength is **266** and **231** respectively;
4. It was reported that during the ongoing FY 2023-24, **133** new R&D Projects and **₹35.56 Crores** grant have been received and which is expected to increase as the Financial Year closing approaches.

Office of International Relations

A. The Director apprised the Board of Governors that IIT Jodhpur with INAE has inaugurated its joint activity center, "**IIT Jodhpur Outreach Center**" at Gurgaon, NCR on 14th November 2023 and the Center is steering up its activities.

B. The Board of Governors was also briefed that the Office of International Relations & Outreach (IRO) has executed more than **25 MoUs** and Agreements with Foreign Institute / University and the major collaborations are :

1. MoU between IIT Jodhpur (School of Management and Entrepreneurship) and **Case Western University** (Weatherhead School of Management in Cleveland, Ohio, USA) for starting an innovative "1+1" Program for MBA-Tech. Students.
2. MoU between IIT Jodhpur and **Case Western University** for enhancing the collaboration in Education and Research.
3. MoU between IIT Jodhpur and **Alliance Française De Jaipur** for running the French Certificate Course for student and IITJ Fraternity.

C. New Admission of International Students at IIT Jodhpur

Recently, 4 Students form EPITA France have joined IIT Jodhpur through Student Exchange Programme and 1 Student from Bangladesh has joined IIT Jodhpur through Study in India Programme.

D. Hosted an Augmented Reality Exhibition entitled "Midi Minuit"

IIT Jodhpur hosted an Augmented Reality Exhibition titled "**Midi Minuit**" during 6-12th November 2023 at IIT Jodhpur. This event was conducted through a collaborative effort between the Indian Institute of Technology (IIT) Jodhpur and Alliance Française, Jaipur. It was a part of the French Embassy, French Institute, and Alliance Françaises' celebration of the Digital November month.

E. Shraman Foundation's Student Scholarship Support

<p>SP.13.2.1</p>	<p>To consider the proposal of amendment in the Statutes of the Institute</p> <p>The Director briefed the Board of Governors that the Ministry of Education, Govt. of India has proposed an Amendment in the relevant Clause of the Statutes of all IITs regarding “in the event of the occurrence of any vacancy in the office of the Chairman, Board of Governors”.</p> <p>He further briefed the BoG that any amendment in the Statutes of IITs shall require recommendation of the Board of Governors of IITs and thereafter the assent of The Visitor of the Institute (The Hon’ble President of India) as per the Act & Statutes of the Institute.
